

Supplemental Figure 1: BMI Z score trajectory by racial-ethnic group. The bottom and top of each box denote the 25th and 75th percentiles, the line inside the box denotes the median and the circle is the mean.



Footnote: N: refers to number of observations at each time point. Missing data were mainly related to different lengths of follow-up in the registry. There was no significant difference in participants' characteristics at diagnosis between participants with vs. without missing BMI data except for age and sex which were adjusted for in the model.
